**Human Resource Development in Madhya Pradesh and
Chhattisgarh**

†*752. SHRI KAILASH JOSHI: Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state:

(a) the schemes for human resource development being implemented in Madhya Pradesh and Chhattisgarh;

(b) the details of NGOs implementing these schemes;

(c) the details of amount allocated and spent, scheme-wise and organisation-wise; and

(d) whether government are aware of diversion of funds allocated; if so, the details thereof and the steps being taken to prevent the same?

THE MINISTER OF HUMAN RESOURCE DEVELOPMENT (DR. MURLI MANOHAR JOSHI): (a) to (d) The Ministry of Human Resource Development implements various schemes/programmes for human resource development throughout the country including the States of Madhya Pradesh and Chhattisgarh. These include Central Schemes, Centrally sponsored Schemes, Schemes implemented through NGOs and Externally Aided Projects. Sarva Shiksha Abhiyan (SSA), District Primary Education Programme (DPEP), Operation Blackboard (OB), Integrated Child Development Services (ICDS) Scheme, Rural Women's Development and Empowerment Project are some of the major programmes of the Ministry for Human Resource Development.

Among the major schemes being implemented through NGOs include women's Economic Programme, Short Stay Homes, Education Guarantee

Scheme and Alternative & Innovative Education (EGS&AIE), Area Intensive Programme for Educationally Backward Minorities, Strengthening of Hostel Facilities for girl students, Integrated Education for Disabled Children (IEDC), Mahila Samakhya Programme, Jan Shikshan Sansthan, National Literacy Mission support to NGOs in the field of Adult Education etc. State-wise details of grants of Rs. one lakh and above given to the NGOs, including *inter-alia* in Madhya Pradesh and Chhattisgarh, implementing such schemes are generally given in the annual reports of the Ministry.

Schemes generally have inbuilt mechanism for post-sanctioning monitoring and review. Usually, Utilisation Certificates/Audited Statement of Accounts countersigned by Chartered Accountant are obtained. Periodic inspection visits are also conducted by the officers of the Ministry. A task force has also been constituted to monitor the working of NGOs. In case specific complaints are received regarding misuse of funds by such organisations, the matter is investigated and suitable action, such as stoppage of further grants/blacklisting of NGOs is taken against the NGO if the allegations are substantiated.
