actually processed, as the quality of their available varieties is reportedly not suitable for processing; and

(b) if so, the steps being taken to improve availability of processable grade fruit and vegetable varieties?

THE MINISTER OF STATE OF THE MINISTRY OF FOOD PROCESSING INDUSTRIES (PROF. CHAMAN LAL GUPTA): (a) and (b) Many reasons including non-availability of processable varieties are responsible for low levels of processing of fruits and vegetables. While the Ministry of Food Processing Industries through its plan schemes facilitates higher processing, the requirements of specific varieties of fruits and vegetables are posed to the appropriate institutions in the Ministry of Agriculture.

Terrorist activities In universities

(SHRIMATI) RITA VERMA]: (a) to (c) There is nothing to suggest that terrorist activities are rapidly spreading in the universities in India. There are, • however, some cases in which terrorist activities have come to notice in universities. According to the information received from the Ministry of Home Affairs, "Public Order" and "Police" being State subject, it is for the concerned State Government to devise various methods and take concrete steps to counter terrorist activities in the States. Government has adopted a well coordinated and multi-pronged approach for tackling the activities of militants.
