

R & D activities in university

2840. SHRI NARENDRA MOHAN: Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state:

(a) whether the PM, while addressing Indian Science Congress, had stated that R & D in our university system was not receiving the requisite attention as in specialised agencies and laboratories, whereas science education and research were the fountain-head of all technological development; and

(b) if so, whether UGC is earmarking certain percentage of its grants towards R & D activities in universities and whether this is adequate in the present scenario?

THE MINISTER OF STATE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT [DR. (SHRIMATI) RITA VERMA]: (a) Yes, Sir.

(b) UGC is giving grants to assist the universities towards R & D activities. The quantum of funds depends on the overall availability of funds.

Assistance for studies for economically disadvantaged students

(a) whether Government are considering any new proposal for helping socially/economically disadvantaged and academically bright students for their further studies;

(b) if so, the details thereof; and

(c) if not, the reasons therefor?

THE MINISTER OF STATE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT [DR. (SHRIMATI) RITA VERMA]: (a) to (c) The Government propose to launch several measures addressing the key issues of access, quality and relevance to encourage the students from the socially and economically disadvantaged sections of the society. Besides, Ministry of Social Justice and Empowerment has proposed five new schemes for

academically bright students during the Tenth Five Year Plan (2002—2007) and Annual Plan (2002-2003), viz.:

- (i) Assistance to students belonging to Scheduled Castes for pursuing studies in Residential Public Schools;
- (ii) Setting up Residential schools for Scheduled Caste students studying in classes VI to XII;
- (iii) Merit based Scholarships for the students belonging to OBCs;
- (iv) Merit based Scholarships for the students belonging to Minorities; and
- (v) Scholarships for students with disabilities for higher education.

National network for open school

(a) whether Government are considering to set up National network (N-NOD) for open school; and

(b) if so, the details thereof?

THE MINISTER OF STATE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT [DR. (SHRIMATI) RITA VERMA]: (a) and (b) While there is no such proposal for the school sector, the Tenth Plan proposals submitted by the Indira Gandhi National Open University (IGNOU) to the Ministry of Human Resource Development, Department of Secondary and Higher Education include the proposal of establishment of a National Network for Open and Distance Education (N-NODE) for the Open Learning System.

The above mentioned proposal suggests a network which will connect IGNOU Headquarters with its Regional Centres and its Study Centres and also with State Open Universities.
