(b) whether teachers/employees of Kendriya Vidyalayas have to face problems in regard to Government housing accommodation in schools;

(c) if so, the school-wise, category-wise and division-wise, details of schools where Government accommodation is available;

(d) whether Government have any plan to provide accommodation to all in the near future; and

(e) the details of school where Government accommodation would be constructed in the near future and by when?

THE MINISTER OF STATE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT [DR. (SHRIMATI) RITA VERMA]: (a) and (b) The residential accommodation in respect of Kendriya Vidyalayas located in Project Sector is provided by the Project authorities. In respect of Kendriya Vidyalayas located in Civil & Defence Sector, 50 per cent of the requirement of residential accommodation is to be provided by sponsoring Authority as per terms and conditions of opening of Kendriya Vidyalayas till KVS constructs its own accommodation. However, there arc some Vidyalayas where even this requisite accommodation has not been provided by the sponsoring authorities.

(c) The information is being collected.

(d) As a policy, KVS constructs 11 units of staff quarters (Type I-2, Type II-4, Type III-4 and Type IV-1). However, in case of more demand, additional quarters are also constructed. There is no plan to provide 100 per cent accommodation in the near future.

(e) At present, staff quarters arc under construction in 104 Kendriya Vidyalayas, which arc likely to be completed within the next two years.
