Installation of Telephones by Private Companies

1945. SHRIMATI VANGA GEETHA: Will the Minister of COMMUNICATIONS AND INFORMATION TECHNOLOGY be pleased to state:

- (a) whether private telecom players are set to install phones in rural areas;
- (b) if so, the details of the decisions made in this regard; and
- (c) the terms and conditions decided on network sharing?

THE MINISTER OF STATE IN THE MINISTRY OF COMMUNICATIONS AND INFORMATION- TECHNOLOGY (SHRI TAPAN SIKDAR): (a) Yes, Sir.

- (b) The private Basic Telephone Service providers, who have been granted licence as per the guidelines dated 25.1.2001, are required to set up Points of Presence in urban, semi-urban and rural Short Distance Charging Areas (SDCAs), typically Tehsils, in equal proportion as a part of their roll out obligations.
- (c) Such terms and conditions are a matter of mutual agreement amongst the operators.
