what was initially offered, non availability of adequate facilities of accommodation and food etc. in respect of the persons sent abroad by the registered recruiting agents, are received normally against the foreign employer/sponsor. As and when such complaints are brought to the notice of the Government, Indian Missions/local registered recruiting agents are requested/directed to settle the matter with the help of concerned Government/Sponsors. If the recruiting agents do not comply with the directions of the Government, action is taken to suspend/cancel the registration certificates of the recruiting agents. Foreign employers who violate the terms of the employment are placed in "Prior Approval Category" (Black List). On the recommendations of the Indian Missions abroad, during 2000, 11 foreign employers were placed in the PAC, while 13 foreign employers were placed in PAC during 2001.
