STATUTORY RESOLUTION

**Approving Notification No. 11/2003 - Customs dated January 15, 2003,
seeking to amend the First Schedule to Customs Tariffs
Act, 1975**

THE DEPUTY CHAIRMAN: Now, we have the Statutory Resolution.
Shri Anandrao Vithoba Adsul..... *{Interruptions}*...

SHRI C.RTHIRUNAVUKKARASU (Pondicherry): Madam, I want to make one point....(*Interruptions*)...

THE DEPUTY CHAIRMAN: Okay, let him move it, then, I will allow you. ...(*Interruptions*). Once it is moved,, then only you can seek clarifications. Let him move it. It is not yet there before the House for consideration.

THE MINISTER OF STATE IN THE MINISTRY OF FINANCE AND COMPANY AFFAIRS (SHRI ANANDRAO VITHOBA ADSUL): Madam, I beg to move:—

"In pursuance of sub-section (2) of section 8A of the Customs Tariff Act, 1975, read with sub-section (3) of section 7 of the said Act, this House hereby approves of Notification No. 11/2003-Customs, dated January 15, 2003, (G.S.R. 32 (E), dated January 15,2003) which seeks to amend the First Schedule to the Customs Tariff Act, 1975 so as to enhance the rate of customs duty applicable to goods falling under sub-heading No. 0703.20 from 30% to 100% and preferential rate of duty from 30% to 90% in respect of imports from preferential areas."

The question was proposed.

THE DEPUTY CHAIRMAN: Mr. Soz, what have you to say?

PROF. SAIF-UD-DIN SOZ (Jammu and Kashmir): Madam, Chairperson, many papers are laid on the Table of this House.

THE DEPUTY CHAIRMAN: He has some objection to this.

PROF. SAIF-UD-DIN SOZ: I have given a proper notice.

THE DEPUTY CHAIRMAN: Yes. He has given a proper notice. He wants to say something on this Resolution itself.

PROF. SAIF-UD-DIN SOZ: Sir, you will appreciate it.

THE DEPUTY CHAIRMAN; It is already moved.

PROF. SAIF-UD-DIN SOZ: Madam, many papers are laid on the Table of this House. After some time, the Members don't have any idea about that because there is a lot of other business. And, the basic question

is that the whole House trusts that the Government will not take any wrong step. That trust remains and will continue to remain. But, as regards this Resolution, it needs some clarification. This Resolution has already been moved, and it will also be approved. There will be no difficulty, but the point is that—and the hon. Minister will also appreciate it—the First Schedule to the Customs Tariff Act, 1975, is sought to be amended. Subsequent to this amendment, customs duty will be enhanced on certain commodities. You have given the percentages by which it will be increased. It has also been mentioned that, in regard to certain commodities, preferential rate of duty will be enhanced from 30 per cent to 90 per cent, in respect of imports from preferential areas. This august House has no information as to what are the goods on which you are enhancing the tariff. Therefore, Madam, for future, we must lay down some rule. It may be a Government Resolution or any other resolution. The Members of this august House cannot remain ignorant of what is being done. My question is: Will the hon. Minister of Finance and his colleague go into the question and devise an innovation that, at least, next time, in this Resolution, there will be an explanatory note so that we may know on what commodities duties are being enhanced. He must give this clarification first.

THE DEPUTY CHAIRMAN: Okay. *Mantriji*, the hon. Member is saying that the House will pass this Statutory Resolution. You are enhancing certain duties, but in your Statement, you have not mentioned on what commodities, customs duty is being enhanced from 30 per cent to 100 per cent, and on what commodities, preferential rate of duty is being enhanced from 30 per cent to 90 per cent in respect of imports from preferential areas. What are those preferential areas? Which commodities have been covered?

PROF. SAIF-UD-DIN SOZ: And what will be the future action?

THE DEPUTY CHAIRMAN: Yes. The question is that you should bring, alongwith your Resolution an explanatory note clearly indicating what are the commodities on which customs duty is being enhanced. Members of Parliament should not blindly pass any Resolution. Members want to know what the commodities are. Do you have any information now? If you don't have any then, you can bring it on Monday.

SHRI ANANDRAO VITHOBA ADSUL: Madam, just now, I am not having all these details, but, definitely, on Monday, all the details will be circulated.

THE DEPUTY CHAIRMAN: With this assurance given by you today—as it is compulsory to pass this Resolution today, because of the date given—we will get it cleared by the House. But, I underline that there is a commitment by you that, by Monday, you will bring all the details.

SHRI C.P. THIRUNAVUKKARASU: Madam, I have ...

THE DEPUTY CHAIRMAN: Let me finish this Business. Are you talking on this?

SHRI C.P. THIRUNAVUKKARASU: No, Madam.

THE DEPUTY CHAIRMAN: No; okay;

SHRI C.P. THIRUNAVUKKARASU: Madam, yesterday, an important matter...

THE DEPUTY CHAIRMAN: But this matter is more important just now because it is on my table. Let me finish this, and I will call you. I shall now put the motion to vote. The question is:
