Statement reportedly made by the Prime Minister during his speech in Srinagar for improvement of relationship between India and Pakistan

SHRI PRANAB MUKHERJEE (West Bengal) : Sir, we read in the newspapers that the Prime Minister, during his speech in Srinagar, had

made a very positive statement in respect of improving relationship between India and Pakistan. This is a matter of utmost importance to the House. Therefore, in the morning meeting, I sought your permission that I would like to draw the attention of the Government whether the Government or the Prime Minister would be in a position to tell the House and take it into confidence what message did the Prime Minister convey through his speech in Srinagar; what has been the response of Pakistan; and, what follow up action is the Government of India going to take? I would like to submit to the hon. Minister of Parliamentary Affairs to convey the feelings of the House to the Prime Minister and the Government, and get an appropriate response.

Demand for Haj like facilities to other communities

SHRI RAJKUMAR DHOOT (Maharashtra): Sir, I want to raise a very important issue of extending Haj type facilities to other communities in India. India is the largest democracy in the world, which enjoys unity in diversity. It has no religion of its own, and secularism is its way of life. The Constitution of India, *inter alia*, guarantees right to freedom of religion to every citizen; it gives strength to real secularism. But, in a secular State, how long can or should a particular community be given benefits for pilgrimage at the cost of others, who are considered for similar benefits? In the governance of a secular State, all communities pay taxes to the Government. The Government of India spends about Rs. 200/- crores on 89,000 Haj pilgrims, approximately.

(THE DEPUTY CHAIRMAN, in the Chair)

It will be congruent for the Government to demonstrate secular ideology by providing Haj type facilities to other communities, such as, to the Hindus for visiting Mansarovar and *Chaar Dhams*, to the Sikhs for visiting Nankana Sahib, to the Christians for visiting Jerusalem or Vatican City, to the Buddhists for visiting South-East Asian countries, and so on. The Government can enter into a Memorandum of Understanding with the Governments of these countries on the lines of Saudi Arabia. The number of pilgrims can be worked out in proportion to their population or based on other criteria, as is feasible to them. The Central Government may provide funds for this purpose in its Annual Budget so that all communities exalt the feeling of true secularism. I urge upon the Government to give a serious consideration to this aspect so that the feeling of secularism is not vitiated, which is so vital at this juncture. Thank you.
