- (ii) Preventive/predictive maintenance for static and rotating equipment.
- (iii) Control of ignition source by strict adherence to work permit system.
- (iv) Regular training of company's as well as contractors' personnel on safe practices, safe operation, fire-fighting, etc.
- (v) Installation and upkeep of hydrocarbon leak detectors, fire detectors/alarms.
- (vi) Monitoring of SMS through internal safety audits and safety Committees.

Further, Oil Industry Safety Directorate (OISD) conducts an external safety audit of the refinery once in two years through a panel of experts from the oil industry. OISD also conducts surprise safety checks of the refinery every year. The recommendations made by OISD are taken up by HPCL for implementation and are monitored periodically. OSID guidelines as well as other relevant national and international standards are also followed.

Weight of LPG cylinder
