- (b) Representative of Central Ground Water Authority is a member of the Expert Committee for Environmental Impact Assessment of Infrastructural Development & Miscellaneous Projects.
- (c) Decision on project proposals is normally taken within 90 days of receipt of complete information. During the last year, 24 development projects along the coastal region were accorded environmental clearance by the Ministry.

THE MINISTER OF STATE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (DR. VALLABHBHAIRAMJIBHAI KATMRIA: (a) to (d) A Statement is laid on the Table of the House.

Statement

(a) to (d) Guidelines have already been issued by the Cabinet Secretariat in December 1999 regarding clearance for study/research scheme involving foreigners/foreign collaboration from security/sensitivity angle and by the Ministry of Home Affairs in September, 2000 regarding security clearance for holding international conferences/seminars/workshop/etc. in India. The guidelines issued by Ministry of Human Resource Development on 31st January, 2003 mainly relate to the procedure to be observed by Central Universities to enter into an MoU with foreign Universities/Institutions with prior clearance from Ministry of Human Resource Development.

The guidelines in no way discourage genuine research proposals which are being evaluated in consultation with the concerned Ministries.
