Rs. 4526.75 crores was made for the Mid-day Meal Scheme. The allocation for the year 2000-2001 has been fixed at Rs. 3608.75 crores, which is 25% more than the expenditure for the year 1999-2000.

Expenditure for hundred per cent Elementary Education

3698. SHRI SURESH KALMADI: Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to refer to answer to Unstarred Questions 2135 and 2140, given in the Rajya Sabha on 8th December, 2000 and state the expenditure likely to be incurred on the programme to achieve 100 per cent (from the current 70 per cent) elementary education for children between 6 and 14 years of age, by the year 2010?

THE MINISTER OF STATE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (SHRI SYED SHAHNAWAZ HUSSAIN): According to broad assessments made by this Ministry, additional resources of about Rs.60,000 crores are required from the budgets of the Central and State Governments over the next ten years. Since this is a programme for Universalisation of Elementary Education, the actual requirement of funds can only be worked out after the District Elementary Education Plans are finalised.
