Production cost of LPG

SHRI KAPIL SIB AL :

Will the Minister of PETROLEUM AND NATURAL GAS be pleased to state :

whether production cost of LPG has been assessed by Government;

if so, what was the average production cost during 2000-2001, 2001 -2002 and 2002-2003; and

the percentage of taxes, cess and surcharge of the Central and State Governments levied on LPG during the aforesaid years ?

THE MINISTER OF PETROLEUM AND NATURAL GAS (SHRI RAM NAIK) : (a) and (b) The cost of production of individual petroleum products is not identified separately by refineries because all the products are produced together in the refining process. Oil marketing companies pay to refineries the prices of domestic LPG on import parity basis. The average import parity price of domestic LPG during the years 2000-01, 2001-02 and 2002-03 was Rs. 233.25/cylinder, Rs. 191 82/cylinder and Rs. 222.05/cylinder respectively.

(c) The rates of customs duty and excise duty levied by the Central Government on domestic LPG during the years 2000-01, 2001 -02 and 2002-03 were as follows:

In addition to the aforesaid duties by the Central Government, sales tax is levied by the State Governments on this product at rates varying from State to State. The rates of sales tax on domestic LPG in different States during the years 2000-01, 2001 -02 and 2002-03 are given in the enclosed Statement.

the amount proposed to be sanctioned by Government to Himachal Pradesh for encouraging tourism during the year 2003-2004;

whether Government have any scheme to make the Durga Hatkoti temple, which is important from the tourism point of view and where lakhs of devotees come for 'Darshan', more attractive; and

the measures proposed to be taken by Government for the convenience of the tourists ?

THE MINISTER OF TOURISM AND CULTURE (SHRI JAGMOHAN) : (a) During 2003-04, who project has been sanctioned in Himachal Pradesh as yet. However, during financial year 2002-03, 30 projects were sanctioned for Rs.779.32 lakhs for the State of Himachal Pradesh.

There is no such proposal at present in the Department of Tourism.

Development of tourist infrastructure is primarily undertaken by the State Governments/Union Territory Administrations. The Department of Tourism, Government of India, however, provides financial assistance for Integrated Development of Tourism Circuits, Product/Infrastructure and Destination Development Projects and Large Revenue generating projects identified in consultation with them.
