THE MINISTER OF STATE IN THE MINISTRY OF CHEMICALS AND FERTILIZERS (SHRI CHHATTRAPAL SINGH): (a) to (d) BIFR has not sanctioned a viable Rehabilitation Scheme for Hindustan Fluorocarbons Limited so far. The Operating Agency (IDBI) had finalized a Draft Rehabilitation Scheme (DRS) for the Company and forwarded to BIFR in November, 2002.

Southern Pesticides Corporation Limited (SPEC) is presently in the process of winding up under the provisions of Companies Act, 1956. BIFR had ordered closure of the Company after declaring the Rehabilitation Scheme as failed. The Andhra Pradesh high Court had ordered winding up of the Company with effect from 2nd April, 2002 and the affairs of the Company were handed over to the Official Liquidator in July, 2002.
