FOOD AND PUBLIC DISTRIBUTION (SHRI SUBHASH MAHARIA): (a) The quantity of foodgrains stored by the FCI in open godowns termed as CAP (Cover and Plinth) during the last 4 years *i.e.* 1999-2000 to 2002-2003 in the months of June and November each year is given in the enclosed Statement (See below). Generally the quantity of wheat stored in CAP storage is maximum during June while that of paddy is maximum during November.
