However, the Railway Administration assist the GRP in controlling crime over Railways and following steps have been taken by the Railways:

- 1. Steps have been taken to sensitize the RPF personnel to the problems of women passengers by organizing workshops and seminars.
- 2. Ladies' compartments are escorted in some suburban areas by lady constables of GRP and RPF.
- 3. Special squads consisting of ladies ticket checking staff and lady RPF personnel have been formed and are operating in Central, South Central and Western Railways to assist the women passengers.

# **Downsizing in Railways**

(a) whether it is a fact that'human failure' behind rail accidents stems from the paucity of Group 'D' safety category staff and hence Government have decided to fill up 20,000 vacancies therein;

(b) whether it is also a fact that Railways operations are bound to be labour intensive;

(c) whether keeping in mind the safety aspect, RPF and RPSF have been exempted from Government's downsizing policy;

(d) if the answers to parts (a), (b) and (c) are in affirmative how Government explains its policy of downsizing manpower by 2 per cent every year; and

(e) what are the reasons behind accepting the downsizing policy?

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS (SHRIBANDARU DATTATRA YA): (a) Though in majority of the incidences or Railway staff failures, leading to accidents, group'C staff are found responsible, group \*D' staff are feeder categories for promotion to group 'C staff including many vital and safety categories. Hence, it has been decided to fill up more than 20,000 group <sup>4</sup>D' vacancies.

(b) Yes, Sir.

(c) The combatised paramilitary forces have been exempted from the purview of rightsizing, hence efforts are being made for exempting RPF/RPSF from rights izing.

(d) The Railways are trying to reduce manpower by 2% every year to the extent possible. During the past 3 years *i.e.* 2000-01,2001-2002 and 2002-03, Railways have been able to reduce manpower by more than 2%. Based on the projection Railways will be able to maintain the trend of achieving an average of 2% annual reduction.

(e) This is being done as per laid down policy of the Government.

# Failure to achieve production capacity by public sector units

5218. SHRI TARINIKANTA ROY: Will the Minister of RAILWAYS be pleased to state :

(a) whether it is a fact that all the six public sector production units of Railways failed to achieve their production capacity;

(b) if so, the reasons behind the failure;

(c) what steps are being taken to revive the production capacity of these units; and

(d) whether it is a fact that more 'indepence would help these PSUs wriggle out of present condition ?

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAY (SHRI BANDARU DATTATRAYA): (a) No, Sir. All die six production units have achieved their production targets for 2002-03. The production targets were fixed based on traffic requirements as availability of funds.

(c) The Production capacity available in these units is surplus to the present requirements of Indian Railways.
