- (b) whether it is also a fact that the bigger States like Andhra Pradesh, Assam, Madhya Pradesh, Bihar, Orissa and Rajasthan are below the national average in providing access to drinking water;
- (c) if so, the details of the rural households having access to safe drinking water in the country, State-wise; and
- (d) whether Government have any time-bound programme to provide access to safe drinking water to all households?

THE MINISTER OF STATE IN THE MINISTRY OF RURAL DEVELOPMENT (SHRI U.V. KRISHNAM RAJU): (a) to (d) As per information furnished by the State Governments upto February 2003 out of total number of 1422664 rural habitations in country, 1295522 are

fully covered, 112792 are partially covered and 14350 are not covered. Out of these habitations 217211 habitations are affected by quality problems like fluoride, salinity, iron, arsenic nitrate and others.

It is not a fact that bigger States like Andhra Pradesh, Assam, Madhya Pradesh, Bihar, Orissa, Rajasthan are below the national average in providing access to drinking water.
