(c) and (d) The following steps are being taken to curb such pilferages :—

1. Escorting of trains, carrying valuable and important consignments, as far as possible.
2. Intensive beat patrolling in yards and other affected areas/sections.
3. Joint checking at interchange points to take stock of the condition of wagons/seals, carrying consignments.
4. Conducting raids on the dens of criminals and receivers of stolen Railway property in order to bring them to book.
5. RPF armed pickets are posted/deployed in yards as far as possible.
6. Plain clothed RPF personnel are also deployed to collect criminal intelligence with a view to tracking down offenders.
7. Based on criminal intelligence, raids and searches are conducted on the dens of criminals/receivers of stolen property in order to bring them to book.
8. Dog squads are deployed for patrolling in yards and vulnerable areas as per their availability.
9. Close coordination between RPF, GRP and local police is maintained at various levels to apprehend criminals and receivers of stolen property.

A.C. train for local train service

3828. SHRI SANJAY NIRUPAM : Will the Minister of RAILWAYS be pleased to state :

(a) whether Railways propose to introduce air conditioned trains for Mumbai local train service;

(b) if so, the details thereof; and

(c) if not, the reason therefor?

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS (SHRI BANDARU DATTATRAYA) : (a) No, Sir. At present, there is no proposal to introduce air conditioned trains for Mumbai local train services.

Vacancies of Railway Safety Staff

SHRI T.S. BAJWA :

Will the Minister of RAILWAYS be pleased to state :

(a) whether it is a fact that more than 10,000 vacancies of ground level Safety Staff in the Railways are lying vacant;

(b) if so, the details of vacancies lying vacant, zone-wise and the period from which they are lying vacant;

(c) the Special Safety Fund allocated for the years 2001-2002 and 2002-2003; and

(d) the amount that has been spent on safety during the last two years ?

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS (SHRI BANDARU DATTATRAYA) : (a) and (b) Occurrence and filling up of vacancies is a continuous process and filling up is by direct recruitment or promotion of serving employees. While a few vacancies are likely to exist in this continuous process at any given point of time, the policy of the Government is to fill up the vacancies promptly. Details are being collected and will be placed on the Table of the Sabha.

(c) and (d) During 2001-2002, an amount of Rs. 1400 crores (net) was allocated to the Railways out of the Special Railway Safety Fund against which the expenditure incurred has been Rs. 1434.28 crores. In 2002-2003, in the Budget Estimates, Rs. 2210 crores (net) was allotted, which has been increased to Rs. 2310 crores in the Revised Estimates.
